CANCELLATION AND REFUND POLICY

Should a student's enrollment be terminated for any reason, all refunds will be made according to the following refund schedule.

Cancellation can be made in person, by telephone, by electronic mail, or by certified mail.

All monies will be refunded under the following circumstances:

Nouveau Contour Academy does not accept the applicant

The Applicant cancels within three (3) business days after signing the enrollment agreement and making the initial payment

Nouveau Contour Academy cancels the program

Cancellation after attendance has begun, will result in the following refunds:

Tuition will be prorated and computed on the number of hours completed to the total program hours. Any part of a day will be counted as a full day with respect to refund. Minimum refund will be 40% of the total tuition.

Please note that the \$150.00 Registration fee is Non refundable

Termination Date: In calculating the refund due to a student, the last date of actual attendance by the student will be used in the calculation. Any part of a day will be counted as a full day with respect to refund.

Refunds will be issued within 30 days of termination of student's enrollment or receipt of cancellation notice from student.

In lieu of the above stated refund schedule, student may elect to attend/complete the class at a later date.

GROUND FOR TERMINATION
